

Bilateral Agreement for Academic Cooperation

and, on the other hand,

State University of Physical Education and Sport, 22, Andrei Doga Street, Chişinău, Republic of Moldova, represented by Rector, dr. hab., prof., Veaceslav Manolachi

Preamble

Recognizing the mutual benefits through a cooperative programme promoting scholarly activities, scientific co-operation and international understanding **Bogdan Khmelnytsky Melitopol State Pedagogical University** and **State University of Physical Education and Sport**, will enter into this academic cooperation agreement and agree to the following:

1. Subject of the Agreement

The Parties have agreed to establish a mutually advantageous cooperation in the field of higher education and research. Activities include the following:

- Regular exchange of information on joint scientific research.
- Participation of the parties in co-publishing (magazines, books, etc.) in the field of higher education and science.
- The Parties organize and conduct meetings, conferences, symposia and other forms of joint activities in the field of higher education and science in order to exchange knowledge and experience.
- Ensuring academic mobility of students and graduates in order to participate in various academic exchange programs (training courses, summer schools).

Under this agreement, the partner institution will be able to keep its academic staff informed about above-mentioned activities the International Master's Degree Programmes for foreigners, provided in both universities and to facilitate their application to these programmes.

2. Implementation

In order to carry out and fulfill the aims of this agreement, each of the partner institutions shall appoint a Coordinator, who shall manage the development and conduct of joint activities.

Either party may initiate proposals for activities under this agreement.

Specific details of any activity shall be set forth in a Supplemental Letter of Agreement, which shall become an integral part of the general Agreement upon signing by the leaders at each institution. The addendum shall include such items as number and period of student and staff exchange, budgets, and sources of financing, the responsibilities of each party and other items necessary for the efficient achievement of the activity.

3. Duration and termination of the Agreement

This Agreement shall become effective on the date that it is signed by both parties and shall be valid for a period of three (3) years, but may be renewed or extended by mutual consent.

Any changes to this Agreement shall be subject to the written consent of both parties.

Either party may terminate this Agreement at any time if the terminating party gives written notice of its intention at least three months prior to termination.

Any dispute arising under the terms of this Agreement shall be referred to an independent mediator as agreed by both Parties.

In the spirit of international academic friendship and cooperation, we hereby set our signatures.
